# COCA ANNOUNCES NEW BOARD PRESIDENT AND ADDITIONS TO BOARD OF DIRECTORS

COCA Ready for Next Chapter with New Leadership in Kristin Johnson, Principal and Chief Transformation Officer at Edward Jones, as President of COCA's Board of Directors

Kristin Johnson has been a COCA Board Member since 2002 and joined the Executive Committee in 2008, serving in a variety of Vice President roles. As a former ballet dancer, Johnson is a strong advocate for the arts in St. Louis.

As Chief Transformation Officer at Edward Jones, Kristin works to empower, inspire, and mobilize the firm's 52,000 employees to grow their impact on the clients, colleagues, and communities they serve. She joined Edward Jones in 1995 and has held positions within the firm's Internal Audit department, Operations division, Retirement Services and Client Reporting areas, and Human Resources.

Johnson graduated from the University of Illinois with a bachelor's degree in accountancy. She earned a master's in information management from Webster University and completed Washington University's executive MBA program. She is active in several organizations and serves on the boards of Webster University, the St. Louis Fashion Fund, and Mercy Hospital St. Louis.
